2 Chairperson Shannon Barton Stark called the meeting to order at 4:31 P.M.

7 COMMENTS FROM RATEPAYERS:

- 8 Robert Brandt stated I'd like to ask, really, what this meeting is going to be about.
- 9 Shannon Barton Stark stated I think that I'd entertain a motion for discussions about appointing a new
- 10 superintendent, an interim superintendent.
- 11 Robert Brandt stated I'm not sure how this is all going, but I'm resigning.
- 12 Gary Pollender stated so this meeting is null and void.
- 13 Robert Brandt stated no, it's not, you have two, you have a quorum.
- 14 Shannon Barton Stark stated I suppose at this point I make a motion to accept his resignation. "I resign
- 15 my position as Electric Light Commissioner effective 5/2/24. Robert Brandt."
- MOTION was made by Shannon Barton Stark to accept Robert Brandt's resignation. The Motion was
 seconded by Gary Pollender. No discussion.

- 23 APPOINT SUPERINTENDENT:

- 1 Shannon Barton Stark stated I'd like to entertain a motion to discuss the appointment of an interim
- 2 superintendent for a 6-month term.
- MOTION was made by Gary Pollender to discuss the appointment of an interim superintendent. The
 Motion was seconded by Shannon Barton Stark. No discussion.
- 5 Roll Call Vote:

9 The MOTION was approved (2-0)

10 Shannon Barton Stark stated so as far as discussions with this, I've been doing a lot of research. I've been 11 doing my homework and on two visits to the office now; one to talk to Tom and Mike, another one, Tom

 was not in the office, so I talked with Mike. To me, if your truck is broken, you bring it in and get it fixed
- 13 and I feel as though there is something broken here. The office seems to be working fine. There seems to
- be issues in the shop and as someone who grew up here and lived here my whole life, Ludlow Electric is
- 15 a super important part of our town. I think at this point, it is not running properly. I think it hasn't been
- 16 running properly for quite a while now, and so it's time to fix it, and this is a hard position to be in. We
- 17 walked into this just over a month ago, but sometimes you walk into something hard and you're not
- 18 going to make everyone happy and that's the position I'm in. Let's get this fixed. I think, going as an
- 19 interim superintendent, which would be temporary, 6 months, we can see if it's going to make any
- 20 changes and after those 6 months, we can look at something else if it's not working. But in my opinion,
- 21 and my position, I believe there is something that needs to change at this point.
- 22 Gary Pollender stated I've got nothing to say.
- 23 Shannon Barton Stark asked any comments.
- 24 Jay Jurkoic stated you said 6 months.
- 25 Shannon Barton Stark stated an interim of 6 months.
- 26 Jay Jurkoic asked why that number.
- 27 Shannon Barton Stark stated well I think that if we did three months, that's not quite enough time to see
- the changes that we could possibly see. I think 6 months gives us a little time to start seeing if there's any changes.
- Jay Jurkoic asked so in the period, whatever period you decide, are you going to advertise the position of
 superintendent and let whoever apply, apply.
- 32 Shannon Barton Stark stated I believe how that works is we would warn a position to the office first and
- provide applicants there. And I know opinions are tough here, but in my opinion, we have somebodythat knows the job.
- 35 Michael Gadway stated per the book, you have to open up the position, put the position in the town 36 offices, at our office, and at the shop and put it in the local newspaper.
- 37 Gary Pollender asked before you appoint anybody, correct.
- 38 Michael Gadway stated no, to do an interim appointment.
- 39 Gary Pollender stated for now, but then you have to advertise the position.
- 40 Michael Gadway stated but then you have to advertise the position.
- 41 Shannon Barton Stark stated by our local charter, "said board, may, in its discretion, appoint a
- 42 superintendent of Ludlow Light Department, fix his or her compensation, and remove him or her at their
- pleasure." So, as far as the charter goes, the board is allowed to appoint; we do not have to warn theposition.
- 45 Jay Jurkoic stated an interim.
- 46 Shannon Barton Stark stated an interim position, yes.
- 47 Jay Jurkoic stated, but permanent you do.

- 1 Shannon Barton Stark stated permanent, you have to warn it, correct. As far as appointing an interim, we
- 2 as the board have the power to appoint. And again, I've been doing a lot of work, a lot of research. I'm
- 3 taking this position very seriously. I've lived in Ludlow my entire life. I am a ratepayer. I took this position
- 4 because I was going to a lot of board meetings and seeing what was going on and it didn't feel right to
- 5 me, so I ran for this, and this is the position I find myself in. It's not an easy one, but I'm here to do it.
- 6 Michael Gadway asked what are the qualifications for this position.
- 7 Shannon Barton Stark stated that's a good question. I don't have the answer for that right now.
- 8 Michael Gadway asked how can you appoint somebody if you don't know if they're qualified.
- 9 Shannon Barton Stark asked well do you know the qualifications for this position.
- 10 Michael Gadway stated I don't off the top of my head, no, but you're appointing somebody so you
- 11 should know the qualifications.
- 12 Shannon Barton Stark stated you are correct. I do know that appointing somebody that has been in the
- 13 position, assistant position, prior to, has knowledge of where we're going. Now, being an interim
- 14 position, superintendent, that gives us time to look at it and see if this is going to fix things.
- 15 Jean Strong stated my question is kind of a follow up to what you just said, because it seems like that
- 16 position was, I don't know if that position was removed or whatever, so if there was a position there,
- 17 there must've been a job description, I would think, by the management that was in charge of it prior.
- 18 So, there should already be a position with a job description. That shouldn't be new. That should already
- 19 be there. Right.
- 20 Michael Gadway stated it doesn't exist.
- 21 Jean Strong said that doesn't exist.
- 22 Jay Jurkoic stated it wouldn't be hard to write one.
- 23 Jean Strong stated will you let me finish.
- 24 Jay Jurkoic said I'm sorry.
- 25 Jean Strong said so when that position was eliminated or whatever, was there a job description with
- 26 duties for the position that took its place. I mean, it seems like you're starting from scratch anyway. So,
- 27 good luck with it and I think you just got to keep going forward, that's my two-cents.
- 28 Shannon Barton Stark stated one of the sites visits, I went down to the office, I asked to see the agenda 29 and the minutes from the January 25, 2022 meeting that occurred. Reviewing them and looking back on 30 it, there was an illegal decision made. There was a motion made under "other business". So, there are 31 ways we can go about this. Legality-wise, if we look back on that meeting, the position of assistant 32 superintendent was terminated, but not legally. So, and even going back to our handbook, it still has the 33 board, superintendent, office manager. So, it's still saying it in our handbook. The meeting, it was not run 34 properly. The motion was made under "other business". It wasn't a legal termination. We can discuss 35 this, if we wanted to go back and do this legally, he would still be, Brett Sanderson, would still be 36 assistant superintendent. So, there's other ways we could look at this. I felt calling this special meeting 37 was going to be the best way to do it, versus having to go back years and go down that rabbit hole. Quite
- honestly, I think if we did it that way, we'd look into legal ramifications of retro pay and I felt this was the
 better solution, going in and calling a special meeting this way, versus having to get lawyers, go back and
- 40 assess the situation from 2022. It was going to be a messy way to do this.
- Steve Stariknok stated as far as the interim appointment, it doesn't really matter much, but do we have a
 preference or a policy in place when we are warning for a job position that we actually promote from
 within or are we legally allowed to do that.

Shannon Barton Stark stated we are legally allowed to promote from within, yes. Legally, and again, the
board is, in our charter, allowed to appoint a superintendent. We do not have to warn it.

- 48 Steve Stariknok stated I was just looking into the promoting from within policy. You know we talk about
- 49 the benefits packages and things, where we're a small company, room for advancement and looking
- ahead on the position, it's especially nice if you know that preference is given to the people who have
- 51 worked for the company before.

- 1 Shannon Barton Stark stated and we're also looking at, we would have to now bring somebody in and
- 2 train them. Spend all the time doing that and quite honestly, if we are to say warn the position, put it in
- 3 the newspaper and all of this, are we actually putting out a position and giving people hope for a job that
- 4 more than likely we have somebody who can do the job. If someone is qualified and knows the job, are
- 5 we spending the money to advertise. I personally feel as though making an appointment from within is
- 6 going to first off go smoother, hopefully. We do not have to do training. The person is, I believe, the most
- 7 qualified person to promote from within. I know there is promotions that maybe the person wasn't
- 8 completely qualified. I own a cleaning business and I'm here tidying things up.

- Shannon Barton Stark stated I'd like to entertain a motion to appoint an interim superintendent for sixmonths.
- 12 MOTION was made by Gary Pollender to appoint an interim superintendent for six months. The
- 13 Motion was seconded by Shannon Barton Stark. No discussion.
